If false, I already agree to see me apply the sanctions provided for in regulation, including the disqualification of my dog and my exclusion of any event sponsored by the S.C.C.

Place and date: the exhibition will be held on 01/10/2011 in Avignon

Arrival-judgments : Access to the exhibition is open to 8: 30 am. The **judgments will begin at 9: 30 a.m. precise.**

Veterinary service: Veterinary service will be provided by a doctor of veterinary service has all powers to decide on the acceptance, refusal or removal, both at the entrance in exposure, appearing with defects or sick dogs, visibly full dogs, in a State of lactation or accompanied by their young, with female dogs in heat, dangerous dogs.

The decision of the veterinarian is without appeal.

The presentation of the certificate of vaccination against rabies (more than a month) is mandatory.

Cancellation : Where this is impossible to open the exhibition for reasons beyond the control of the organizers, major commitment fees will not be reimbursed, whereas the Club will have to cover the Organization incurred.

Commitments : They will not be reimbursed for non-submission or package after **on 01/10/2011.**

Are only admitted to the exhibition dogs enrolled in a book of origins (book of waiting included) of a member of the F.C.I. or a country not affiliated with the book of origin is recognized by the F.C.I.

Will be refused: registrations received after the closing date of commitments or after **18/09/2011**, commitments to the post the day of the exhibition (except lots of livestock), all changes or registrations in other classes involved on the day of the exhibition. **With respect to the american staffordshire terrier, will be denied the judgments of those who had the ears**

cut off after the ratification, in their country of origin, of the European convention for the protection of pet animals from 13/11/1987 (except for delivery to the judge to a veterinary certificate certifying that the otectomie was made for curative purposes). For the special case of the France, this therefore concerns the dogs born after 28/08/2008.

Judgments : The judges will be assisted in their ring a Secretary and a Commissioner of ring. Judgments are final and definitive as soon as delivered.

Confirmation : Confirmation is open to the dogs with the minimum age of 12 months. They must be necessarily identified by legible tattoo or an electronic chip. Registration card and birth certificate are to apply to the judge of the confirmation application form completed and signed by the owner. Simple confirmation requires that the dog conforms to the standard of the race. Confirmation 1st choice requires, on the one hand that the dog is considered by the judge of a classified EXCELLENT level, on the other hand, that it has successfully passed its Test of skills natural (TAN) with mention EXCELLENT.

T.A.N.:

The natural skills test will take place on 01/10/2011, from 14 hours.

The test of character is mandatory for obtaining the title of champion.

Claims : All claims based on this regulation, except those concerning judgments, whereas these are without appeal, will have to be made in writing by the time of the event which will be motivated and be accompanied by a surety of the amount equivalent to three times the price for the commitment of the first dog to the event which will remain acquired the Club if, after review by a Committee composed of members of the Committee present, they are recognized without foundation.

Sanctions: Can be excluded temporarily or permanently of the exhibitions and competitions organised by the CSC with possible extension to the events organized by its affiliated associations: exhibitors visiting guilty of facts against the honour, those who have made a false statement, those who have their dog any likely mislead on quality operation, those who have made a false statement, **those who by their language, their writings, their actions detrimental to the success of the exhibition or would impair the prestige of the judges and the F.A.B.A.S. Club**, which will be introduced surreptitiously a dog not hired or replaced by another dog. **The fact of belonging to a Club or a canine society not affiliated to the CSC, will lead to its author and his dog the exclusion of any affiliated group and all events sponsored by the CSC. The sanctions will be imposed in accordance with articles 30 and 36 of the rules of procedure of the CCS.**

Responsibility : The F.A.B.A.S. Club declines any responsibility of the Chief of flight, loss, leakage, illness, death of dogs exposed, bites caused by them, etc, and in some cases or for any cause whatsoever.

Photos : in order to feed the club newsletter and website, exhibitors accept that their dogs are filmed or photographed, this purpose non-commercial.
