**OFFICIAL CONTEST RULES**

**Important: Please read these Official Rules before entering this online contest (the "Contest"). By participating in the Contest, you agree to be bound by these Official Rules and you represent that you satisfy all of the eligibility requirements below and that you comply with all respects with these Official Rules and all applicable laws.**

***NO PURCHASE, PAYMENT, OR FINANCIAL CONTRIBUTION OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST. PURCHASE, PAYMENT OR FINANCIAL CONTRIBUTION WILL NOT INCREASE ODDS OF WINNING. CONTEST VOID WHERE PROHIBITED BY LAW.***

**1. Eligibility.** CONTEST OPEN ONLY TO INDIVIDUAL PERMANENT LEGAL RESIDENTS OF THE FIFTY UNITED STATES WHO HAVE REACHED THE AGE OF MAJORITY IN THEIR STATES OF RESIDENCE (18 YEARS OF AGE IN MOST STATES) AND ARE ABLE TO ENTER INTO BINDING LEGAL OBLIGATIONS AT TIME OF ENTRY. BUSINESSES, CORPORATIONS, REGISTERED FEDERAL LOBBYISTS, REGISTERED FOREIGN AGENTS, FEDERAL POLITICAL ACTION COMMITTEES, NATIONAL BANKS, FEDERAL CONTRACTORS, LABOR ORGANIZATIONS OR OTHER ENTITIES ARE NOT ELIGIBLE TO ENTER OR WIN, NOR MAY ANY INDIVIDUAL ENTER ON BEHALF OF ANY SUCH ENTITIES. ("SPONSOR") RESERVES THE RIGHT NOT TO AWARD ANY PRIZE TO YOU. To be eligible to win, entries must comply with all Contest requirements and be completed and received by Sponsor in the format and within the time period designated below. This Contest is subject to all applicable federal, state and local laws and regulations, including, but not limited to, regulations issued by the Federal Aviation Administration ("FAA").

**2. Sponsor.** The Contest is sponsored by Parrot SA., a French company incorporated in Paris under company registration number 394 149 496, with share capital of EUR 1 895 527.92, having its registered office located at 174 quai de Jemmapes, 75010 Paris (France). All rights to any third-party (including YouTube) trademarks or trade names mentioned herein or in connection with the Contest are the property of the respective trademark or trade name owner. The use or mention of such third-party trademarks or trade names in these Official Rules or in the Contest is solely for descriptive purposes and shall in no way imply that third party's endorsement or sponsorship of the Contest.

**3. How to Enter.** Online entries only. Limit one (1) entry per YouTube account. Each entry must be a previously unpublished original work of the person identified in the entry. If persons other than the entrant participated in the creation of the entry, the entrant must have written permission from each contributor prior to submission of the entry. Participants may enter as follows:

- Brightness: filming in conditions of optimum light;
- Shot with Bebop Drone only, little or no editing;
- Respect of local regulations;
- Duration: 60 seconds max;
- General rendering, aesthetic sense and story-telling.

**Entrants are required to abide by all applicable local, state, and federal law and regulations at all times in connection their participation in the Contest, in particular with respect to drone use and privacy laws.** If Sponsor determines, in Sponsor's sole discretion, that an entrant or submission has violated applicable law or regulations, the submission will be automatically disqualified. Please review all applicable local, state, and federal laws, including FAA regulations and guidelines, related to drone use.

By participating in the Contest, each entrant unconditionally and irrevocably accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, including the interpretation of these Official Rules and exercise of the Sponsor's discretion, which will be final and binding in all respects. Failure to timely submit all required information in the manner required in these Official Rules and/or any entry may result in disqualification. Proof of online entry will not be deemed to be proof of receipt of entry by Sponsor. All entrants and entries are subject to verification by Sponsor.

Entries will be disqualified if they are late, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost or misdirected, deceptive, in excess of the stated entry limits, or otherwise not in compliance with the Official Rules. Subsequent attempts or entries made by the same individual using multiple or false contact information or otherwise will be disqualified. Entries generated by a script, computer program, macro, programmed, robotic, or other automated means are void *ab initio* and are automatically disqualified.

Entries may not contain any material that is or may be: (i) threatening, harassing, degrading, or hateful; (ii) fraudulent or tortious; (iii) defamatory; (iv) obscene, indecent, or otherwise objectionable; (v) protected by intellectual property law, including but not limited to patent, trademark, or copyright law, unless entrant has the prior written consent of the intellectual property rights holder; (vi) dangerous or potentially dangerous, or which would encourage dangerous behaviors, including but not limited to explosives or harmful substances; or (vii) in violation of applicable law, including applicable criminal law.

**4. Contest Period.** The Contest starts at 12:01 a.m. CET on **July 27, 2015** and ends at 11:59 p.m. CET on **September 15, 2015** (the "Contest Period"). All entries must be posted on YouTube platform with the tag #BEBOPYOURWORLDSEASON #USA during the Contest Period to be eligible to win. Sponsor's (or its authorized representative's) computers or server is the official time-keeping device for all matters related to the Contest. All times referenced are Central European Time.

#### **5. Judging Criteria.**

All the entries will be judged by a jury composed of three persons from Sponsor's marketing team.

To be judged by the jury, all entries should respect the theme described in Section How to Enter.

Sponsor reserves the right to disqualify any entry which Sponsor determines, in its sole discretion, does not comply with the Official Rules. The judges' decision is final.

**6. Grand Prize.**

One (1) winner will be selected from all eligible entries in accordance with the Judging Criteria and will receive:

**7. The winner is solely responsible for complying with all applicable laws, taxes, fees, insurance, surcharges, or other costs related to receiving, claiming, or collecting any prize.

**8. Identity of Entrant.** In the event of a dispute about the identity of the entrant, entries will be declared made by the authorized account holder of the YouTube account on which the video is posted at time of entry. The potential winner may be required to provide Sponsor with proof that the potential winner is the authorized account holder of the YouTube account associated with the winning entry.

**9. Grand Prize Winner.** The Grand Prize winner will be determined from all eligible entries received by Sponsor in accordance with the Judging Criteria listed in these Official Rules. Sponsor has absolute and sole discretion in determining the winner. Potential winner(s) will be notified by e-mail on or about **September 22, 2015**. To claim the prize, the potential winner

should follow the instructions contained in his/her notification. Failure to follow the directions in the notification in a timely manner may result in the winner forfeiting the Grand Prize.

**10. Limitations of Liability.** The Released Parties are not responsible for: (i) technical failures of any kind, including but not limited to the malfunctioning of the website code or any computer, cable, network, hardware or software, delay in operation or transmission, communications line failure, technology outage, theft or destruction or unauthorized access to or alteration of entries, whether caused by the sender or any of the equipment or programming associated with or utilized in the Contest; (ii) the unavailability or inaccessibility of any transmissions or telephone or internet service; (iii) unauthorized human intervention in any part of the entry process or the Contest; (iv) electronic, clerical or human error which may occur in the administration of the Contest or the transmission, receipt or processing of entries or notification of winner(s); or (v) any injury or damage to persons or property, including but not limited to entrant's person, drone, camera, computer, hardware or software, which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest. Under no circumstances, including negligence, shall the Released Parties be liable for any direct, indirect, incidental, special or consequential damages that result from the use of or inability to use the YouTube platform, or out of any breach of any warranty. This exclusion or limitation of liability will not apply to the extent that any applicable statute prohibits such exclusion or limitation of liability. **WITHOUT LIMITING THE FOREGOING, EVERYTHING ON THE VARIOUS SPONSOR'S PAGES IS PROVIDED "AS IS" WITHOUT ANY WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT. SOME JURISDICTIONS MAY NOT ALLOW THE LIMITATIONS OR EXCLUSION OR LIABILITY FOR**

INCIDENTAL OR CONSEQUENTIAL DAMAGES OR EXCLUSION OF IMPLIED WARRANTIES; CHECK YOUR LOCAL LAWS FOR ANY RESTRICTIONS REGARDING THESE LIMITATIONS. Any provision of these Official Rules deemed unenforceable will be enforced to the extent permissible, and the remainder of these Official Rules will remain in effect. Sponsor reserves the right to change these Official Rules at any time, in its sole discretion, and to suspend or cancel the Contest or any entrant's participation in the Contest should viruses, bugs, unauthorized human intervention or other causes beyond Sponsor's control affect the administration, security or proper administration of the Contest, or Sponsor otherwise becomes (as determined in its sole discretion) incapable of running the Contest as planned.
