If this were true, I will have no problem to get the required documents to be able to travel on the road, the professional and salesman it is you, but what I received does not correspond to the standards, does not correspond to my order, and impossible to have the authorization because the standards are not respected for the part chassis, braking, wheels, it is not enough to say a number of chassis, for the automatic brakes by For example, you have to have the brakes on the 4 wheels, I have that on 2 wheels braked, already just because of this, impossible to homologate the trailer. So how do I do now? The brake system on the front ball buckle must also have the Europe standard, an engraving of the number on the ball clamp, and an explanation or a notice explaining how it works, how to operate it, how to adjust the brakes of circulation. ... I do not have the information, no tamper-proof numbers engraved on the chassis, no number on the fastener, no plate with measurements and infos mandatory for France to circulate, I can not work with the trailer. Do you think I will leave the situation as it is now?, I can not go on the road with the trailer, the police forbid it, how I do? All my money went into manufacturing and shipping costs, I, I can not do anything with this trailer that I received, and that's my responsibility? You are perfect, you have nothing to reproach yourself, you perfectly filled your order for me?

I think that disputes over alibaba, with plenty of sites created every day, plus articles written in all forums will do much harm to your business if I remain fake, and it will do good to others so as not to be rip off like you stole me with your lies, no, you are not professionals, and this will be known, I will put all my time, you will lose much more than 3500 €, you do not know who I am on the internet, you will quickly understand and everyone will know how you work in real ...

This message is the last, in 8 days, I start a flood of messages, sites about you and your company, discussions on all forums, and believe I will spend a lot of time dealing with your reputation on the internet, I am very motivated to make my story known, I will be as wicked as possible, while telling the truth about how it goes with you, when you order a trailer, and what is delivered to Le Havre. And how you took my money from me, while I found myself with a trailer not accepted on the road, and therefore unusable. You want war? I am ok, because very fake.

I do not even want an answer here, just the transfer before September 12 on my bank account by swift transfer, this transfer will end the story with you, or will be the beginning of many, many messages on the internet.

I immediately open a message of dispute over alibaba so that alibaba is informed in what situation I find myself today because of this fraudulent and dishonest importation.

I will look at my bank account on the 11th or 12th of September, only that, no more messages with you, never ... and you fix your error, we will stop there, and I will not tell anything, I will do what I promise you, I swear to you on the head of my children, I will not let things like this, it is inadmissible, you have my \$ 12,400, me what I have is unusable.
